13/2024 Could the Hon. Minister for Information, Communications and Technology inform the Honourable House about the level of progress in relation to the construction of the Disaster Recovery Site facility in Lubombo?

03/2024 Could the Hon. Minister for Foreign Affairs and International Cooperation inform this Honourable House about the overall financial status of the Eswatini Embassy to the United Nations, including the reports that staff goes for months without salaries?

Minister for Economic Planning and Development inform this Honourable House if his Ministry is still relevant as a powerhouse for the country's economic planning/growth or its prominent role has shifted more towards being a champion of failure in infrastructural project implementation, that continues to be an unending heavy drain of financial resources?

Minister for Finance should, within a period of seven (7) days, provide a detailed response to the honourable House on how more than 890 000 internal records from the Eswatini Financial Intelligence Unit (EFIU) got into the hands of non-profit entity called the Distributed Denial of Secrets that is now known as "the largest leak of its kind from a Financial Intelligence Unit in an African country". Has anyone been held accountable for the leak? What measures, if any, have been put in place to ensure that such a leak does not happen in future? Why should financial and institutions have confidence non-financial that their information with the EFIU is safe and well protected?

To move that the Hon. Minister for Public Works and 07/2024 Transport within a period of seven (7) days, provide this honourable House with a report detailing whether the Resettlement Plan that was prepared in terms of the Compliance Mitigation Plan of the Mbabane bypass road (MR3) was followed to the letter in compensating residents of Mangwaneni, Manzana and Makholokholo who were affected by the construction of this road. The report should include the number of houses that were constructed for the affected residents and the number of residents who had actually filed claims for compensation. The report should also include the amount of money that as budgeted for the compensation and the amount of money that was actually spent for the Further, the report should state how the compensation. Ministry complied with a High Court judgement issued on 25<sup>th</sup> October, 2007 ordering the activation of the Bypass Resettlement Committee to address the plight of the affected residents.

08/2024 To move that the Minister for Information Communications and Technology (ICT) urgently addresses the critical need for the implementation of a comprehensive, end-to-end National Cyber Security Strategy to fortify the kingdom's security infrastructure, safeguard sensitive data, and mitigate the risk of unauthorised breaches, particularly in the wake of recent cyber-attacks on Eswatini's digital assets.

This cyber security framework should include, but not limited to;

- 1. Strengthening encryption protocols to secure sensitive data transmission.
- 2. Implementing robust authentication mechanisms to prevent unauthorised access.
- 3. Enhancing monitoring and detection systems to identify and mitigate cyber threats promptly.
- 4. Providing comprehensive cybersecurity training and awareness programs for government officials and employees.

A progress report should be tabled in the House within twenty one (21) days after adoption of this motion.
