MOTION OF URGENT PUBLIC IMPORTANCE

01/2025 To move that having had torrential rains in the year 2024/25 that destroyed the road infrastructure in the whole country in unprecedented fashion causing calamity;

Taking into consideration the Prime Minister's desire to have roads machinery purchased for each of the four regions with a view to compliment the work of the Public Works department;

Noting the need for an integrated approach to the whole system of the improvement of the road networks;

Further noting the frustration of Members of Parliament caused by the dilapidated road network and the insufficient roads maintenance, construction and repair equipment available;

Whilst appreciating the Government's efforts to improve roads infrastructure and maintenance through the newly established Roads Agency;

We therefore, hereby resolve that;

The Micro-Project Unit in the Ministry of Economic Planning and Development, is given the added responsibility to establish a sector within its Unit that will attend to certain segments of the rural roads using roads equipment, especially the feeder roads that to date remain impassable in the rural communities.
