Given the pressing national need to ensure food security, job creation and empower local farmers – especially smallholder and emerging farmers – why has the Ministry of Agriculture not yet made all agriculture implements duty-free as the current import duties on farming equipment are directly contributing to higher food prices, low productivity, and a growing dependency on foreign aid?

The Bill should be ready for tabling within 30 calendar days.

- 2. At EBIS, international travel opportunities are allegedly monopolised by the newsroom, with little to no inclusion of other departments. At Eswatini TV, Junior Officers are denied opportunities to cover international assignments;
- 3. The allegedly persistent lack of basic working tools and essential broadcasting equipment, such as failure to procure a UPS (Uninterrupted Power Supply) resulting in signal loss and interruptions.

The Hon. Minister must table a report on these issues within seven (7) days after the adoption of this motion by the Hon. House.
