To move that the Hon. Minister for Finance tables a report in the Hon. House within seven (7) days after adoption of this motion on the continued delays by the Motor Vehicle Accidents (MVA) Fund in making payments to road accident victims as these delays cause them financial and emotional strain.

To move that the Hon. Minister for Labour and Social Security appraise the members of this House on plans to establish an Authentic Academy for the training of security personnel to be

deployed across government ministries, the private sector, and the country at large. This motion further calls for the urgent regulation of the security sector and the formal establishment of a vetted and accredited body of security personnel. Given that many individuals currently stationed in even the most sensitive government locations may not have undergone proper training or loyalty assessments, the absence of a centralized and certified training institution poses a serious national security concern. Establishing such an academy would ensure that those entrusted with safeguarding national interests are adequately trained, vetted, and loyal to the Kingdom of Eswatini. The Hon. Minister should table a report within twenty (21) days after the adoption of this motion.

To move that a Select Committee of Members of Parliament be appointed to investigate the closure of four liquor establishments near the University of Eswatini and make recommendations to Parliament on an appropriate solution.

The Committee should:

1. Engage with the Hon. Minister for Commerce, Industry and Trade to understand the process and rationable behind the decision.

- 2. Consult with the affected stakeholders, including business owners, surrounding communities, and representatives of the facilities' users.
- 3. Examine the evidence, considerations, and alternative measures that could have been implemented to address the stated concerns, such as phased closures, reduced operating hours, stricter enforcement, or compensation for business owners and employees.
- 4. Assess the alignment of the closure with the Citizens Economic Empowerment Act of 2023 and its broader implications for the promotion of local entrepreneurship.

The Select Committee should present its findings and recommendations to Parliament within 30 days of its appointment.

HAVING considered the multiple appointments of the same officials to multiple Boards in the parastatals and institutions where Government has a stake, with glaring conflict of interest and lack of cooperate governance;

NOTING that the State Owned Entities' directorships are dominated by individuals whose performance is wanting because of their full-time occupation or employment and worse still, appearing more than once in such Boards;

COGNISANT that Senior Managers in some cooperate entities or parastatals are bosses in other parastatals by virtue of their positions as Chairpersons;

AWARE that the calibre of some of the individuals appointed to SOE's has degenerated over the years resulting in mismanagement and lack of direction in the parastatals; and ALSO aware that there is a financial assistance provided by the AfDB for the transformation of the Public Enterprises Unit.

THEREFORE, the House resolves that the Minister for Finance also in his capacity as Chairperson of the SCOPE should ensure that;

- 1. No individual employed by a parastatal will be allowed or appointed to serve in two (2) Boards of Directors, however, no more than two (2) statutory Board appointments shall be allowed for each government official; and
- 2. That the reviewal of the legislation governing the Public Enterprises Unit, that seeks to strengthen its administration and legislative role in the management of same, is presented to Parliament, without delay.
- 3. The Minister is hereby given sixty (60) working days to align the parastatals in accordance with resolution one (1) with a view to improve efficiency, good cooperate governance and accountability.
- 4. Failure to do so, may lead to serious repercussions during the PEU's annual budget deliberations.
